Good morning,

I am hoping that all of the unauthorised signs throughout the village are removed as requested by the 16 June and that no further action is required beyond that date but I must advise you that unlike many other aspects of planning it is a criminal offence to display signs without the necessary consents in place. If the signs are not removed by the 16 June then enforcement action to secure their removal will commence and is likely to be referred directly to the local magistrates court where upon successful prosecution there is a maximum fine of £2500 for each separate offence (section 224 (3) of the Town & Country Planning Act 1990). As previously mentioned the council must be seen to be open, transparent and consistent when applying enforcement policy particularly as the signs are now the subject of a complaint .

If you wish to apply for advertisement consent to retain the signs then an application will be required for each sign and the application fee will be £385 per sign. The forms can be downloaded on the following website and/or filled in on-line www.planningportal.gov.uk
